#### Job Overview

We are looking for SLTs to join our growing team. The successful applicant will have a real passion for changing the lives of young people and their families. The SLT will share their knowledge and provide support to upskill and empower the child's educational establishment and their wider support team.

The purpose of this role is:

- To manage a small caseload providing direct 1:1 and group therapy, programmes, training and support for CYP in their homes and educational placements.
- To attend meetings and provide reports as required, including Annual Reviews.
- To work collaboratively as part of a multidisciplinary team providing support and practical advice for the team including families, education and other health professionals around the child on how to optimise the communication environment and their own communication to meet the needs of the child.
- To develop resources and devise training packages alongside other SLTs for the team.
- To work with the team of therapists for the ongoing evaluation and development of the SLT service delivery to support children with SLCN.
- To provide support for other members of the Speech and Language Therapy team including Speech and Language Therapy students and Assistants.

#### Qualification, relevant knowledge, and skills required

Main Duties/Responsibilities



- 1. Undertake clinical work with individuals and groups of clients. Develop coordinated multidisciplinary programmes of care/care packages. May work independently or with other SLT colleagues, or as part of a multidisciplinary team. Provide advice, strategies and programmes, as appropriate to the team around the CYP including parents/carers.
- 2. Provide direct 1:1 and group therapy, programmes, training and support for CYP in their homes and educational placements.
- 3. Establish and maintain liaison with parents/carers and other professionals for the comprehensive management of clients. Includes attendance and participation at case conferences and annual reviews.
- 4. In all situations, will communicate complex and sensitive information to clients/parents where there will often be significant barriers to understanding.
- 5. Work collaboratively as part of a multidisciplinary team providing support and practical advice for the team including families, education and other health professionals around the child on how to optimise the communication environment and their own communication to meet the needs of the child.
- 6. To attend meetings and provide reports as agreed in the individual CYP contract, including Annual Reviews.
- 7. Maintain and provide accurate and timely documentation e.g. patient records and reports, sharing with others as appropriate, observing data protection guidelines.
- 8. Ensure good time keeping and planning, to execute the role effectively.
- 9. Record contact electronically within 24 hours.
- 10. Adhere to procedures, policies and standards for service delivery within own specialist area and advise line manager of any resources required.
- 11. Demonstrate progression of clear therapeutic aims as appropriate to clinical setting, with the use of outcome measures.
- 12. Establish and maintain liaison with parents/carers and other professionals for the comprehensive management of clients. Includes attendance and participation at case conferences and annual reviews.
- 13. Refer matters that may impact on service delivery to Line Manager or other authority before taking action.
- 14. Follow best practice SLT standards in accordance with national, regional and professional standards.
- 15. Be responsible for ensuring that own practice is safe and appropriate in accordance with RCSLT and HCPC. Including taking responsibility for own clinical supervision and CPD. Meet the required level of continuing professional development as stated by RCSLT.
- 16. Provide support for other members of the Speech and Language Therapy team including Speech and Language Therapy students and Assistants.
- 17. Signpost SLT colleagues, education colleagues and parents to information on SLCN.
- 18. Collect statistical data and be involved in the use of audit and outcomes to measure and improve quality of care.



- 19. Observe personal duty of care in relation to equipment and resources in course of work and highlight the need for ordering further equipment as required.
- 20. Maintain and update knowledge base in working area, to expand role and autonomous working.
- 21. Share learning from specialist areas of interest including input when developing and delivering team objectives.
- 22. Collaboratively work with Therapists for the ongoing evaluation and development of the service.
- 23. Identify and evaluate evidence and to contribute to Team Evidence Base.
- 24. Collaborate with colleagues in health and education to share current practice and developments relevant to children with SLCN and associated conditions.
- 25. Access documents and information on current and new resources relating to caseload and inform the team
- 26. Propose, contribute to and develop procedures, policies and standards for service delivery within own specialist area, and advises line manager of resources required.
- 27. Provide prospective SLT undergraduates and other professionals the opportunity to observe the work of a SLT. Contribute to the supervision of students.
- 28. Contribute to designing and implementing training to SLTs, SLT students, educational establishments and other agency personnel, parents/carers, individually and/or in groups on specific SLT related knowledge and skills.
- 29. Attend and provide input at SLT service meetings, multidisciplinary meetings and external multiagency meetings.
- 30. Actively participate in receiving:
  - 1. Individual personal development programme/appraisal
  - 2. Peer review
  - 3. Reflective practice
  - 4. Clinical supervision
- 31. Independently identify own development needs and discuss with Line Manager.
- 32. Undertake any other duties of a similar nature consistent with the responsibilities of this post to provide a quality speech and language therapy service.
